

Consultation on Proposed Amendment to Admission Arrangements for Entry in September 2027

Dovers Green Infant School (Rushetts Road, Reigate, Surrey RH2 7RF)

1. Introduction

Greensand Multi Academy Trust is the admission authority for Dovers Green School. In accordance with the School Admissions Code (2021), the Trust is consulting on a proposed change to the school's admission arrangements for entry in September 2027.

The Trust is proposing to reduce the school's Published Admission Number (PAN) to better reflect current and projected pupil numbers within the local area. No other changes to the admission arrangements are proposed. The PAN for entry in September 2026 is 90, and the Trust proposes to reduce this to 30 for entry in September 2027 to reflect falling pupil numbers and ensure efficient use of resources.

2. Consultation Period

This consultation will run for a period of seven weeks, from Monday 1st December 2025 to Monday 19th January 2026.

All responses must be received by 19th January 2026.

We welcome views from parents, carers, staff, governors, local residents, other schools, and the wider community.

4. Proposed Amendment

Aspect	I I	Proposed Amendment (from September 2027)	Rationale
Published Admission Number (PAN)	90	30	The proposal reflects a decline in pupil numbers within the local area and aims to ensure that the school operates efficiently while maintaining high-quality education provision. The proposed PAN is sufficient to meet projected local demand for school places.

All other elements of the school's admission arrangements, including oversubscription criteria, will remain unchanged.

Following the consultation period, all responses will be carefully considered by the Greensand Multi Academy Trust Board of Trustees.

The determined admission arrangements will be published on the school and Trust's website by 15th March 2026, in line with statutory requirements.

If approved, the new PAN will apply to the Reception intake in September 2027 and to all subsequent intakes, unless further changes are made following consultation.
